Approval of Minutes

Vice-Chair Lail noted that the minutes of the April 20, 2022 Full Council meeting were received via email prior to the meeting and included in the meeting packet. Scott Burnett made a motion that the minutes from the April 20, 2022 Full Council meeting be approved as presented; the motion was seconded by Tim Hall and was approved by unanimous vote.

Financial Reports

Bryan David reviewed the Financial Reports that were included in the meeting packet for period June 1, 2022 to June 30, 2022. Scott Burnett made a motion that the Financial Reports for period ending June 30, 2022 be approved as presented; the motion was seconded by Jeremy Satterfield and was approved by unanimous vote.

GO Virginia Region 3 Project Funding Matrix Report

Bryan David reviewed the Project Matrix that was included in the meeting packet for the period.

SPECIAL APPEARANCES & PRESENTATIONS

- The Region 3 Council recognized Randy Lail for his leadership as Chair since the Council was established in 2017. It was noted that Mr. Lail has given significant time and effort to building Region 3 to be a strategic economic development partner in Southern Virginia and to the betterment of the GO Virginia program statewide. A motion was made by Scott Burnett to adopt a formal Resolution recognizing Randy Lail for his dedication and outstanding leadership of the GO Virginia Region 3 Council; the motion was seconded by Charles Majors and was approved by unanimous vote.
- Dwayne Yancey, Editor of Cardinal News, addressed the Council. He discussed the media outlet's emerging role as a news source for Southern Virginia.
- Dr. Julie Brown, Vice President Advanced Learning, and Jesse Vernon, Program Manager, at the Institute for Advanced Knowledge and Research (IALR) made a presentation on the ExperienceWorks Project's implementation and detailed its current status. They discussed how this project utilized the previously funded MajorClarity project to achieve success and how it further supports the successful GO TEC program.

OLD BUSINESS

Approved Projects Updates

The approved projects currently being implemented were presented as follows:

- Bridge To Recovery Project A total of 77 applications have been approved totaling \$636,000 and 77 suppliers have been qualified. DHCD GO Virginia staff approved a no-cost extension for this project through 12.31.22 to complete its outreach program.
- Southern Virginia Regional Alliance Site Development Project Engineering and due diligence bids are underway and work is anticipated to proceed and be completed in the anticipated timeline.
- GO TEC Phase 2B Project One-on-one training for GO TEC Career Connection teachers continues. The subcontract with Carroll County was amended to include new Career Connections modules to support precision agriculture and biotechnology. Negotiations are underway with the Controlled Environment Agriculture Innovation Center to pilot a vertical ag unit for inclusion in Career Connections.
- Experience Works Project IALR Work-Based Learning (WBL) coordinator held the quarterly Major Clarity Partners Meeting for all the school division partners to discuss current usage, achievements, goals, best practices, and challenges.
- Controlled Environment Agriculture (CEA) Project The CEA Contract has been executed. No other activity to date.
- Entrepreneurship & Innovation Implementation Project Regional convening continues with virtual meetups, Rise & Shine networking events are held twice a month, and ongoing planning meetings with partners continue. Access to capital strategy discussions continue with written reports/recommendations in progress.
- SEED Innovation Hub Project Longwood submitted an EDA funding request for Project SEED/Farmville Innovation Hub and has received a non-binding letter of commitment.

- Virginia's Growth Alliance (VGA) Refresh/Restart Project The procurement for services process is underway and work is anticipated to proceed and be completed in the anticipated timeline.
- Mid-Atlantic Broadband Middle Mile Planning Project Notice to Proceed was issued to the engineer on January 7, 2022. Engineering, design, and environmental is approximately 20% complete.
- Mid-Atlantic Broadband Middle Mile Construction Project An EDA grant application was submitted in March 2022. The EDA obligated all their funding prior to reviewing the MBC application, this application was not approved. NTIA funding is being researched at this time; the deadline for application submission is September 2022.
- The Gupton Initiative This Project has been approved and the contract is in the process of being executed.

Vice-Chair Lail asked members for questions or comments; there being none, there was no discussion regarding the updates.

Project Pipeline Updates

Bryan David provided Council members with updates on the project pipeline. Vice-Chair Lail asked members for questions or comments; there being none, there was no discussion regarding the updates.

NEW BUSINESS

Nominating Committee Report

The Region 3 Council appointed Tim Clark as Chair and Randy Lail as Vice-Chair for the 2022-2023 term. In addition to these appointments, the Nominating Committee advised that it would be recommending individuals to serve the unexpired terms of Karl Stauber (7.21.21 - 6.30.25) and Roger Scott (7.1.19 - 6.30.23). The Committee continues to work towards identifying and recruiting a replacement for Roger Scott, who represented the private sector-business membership category. It is anticipated that a candidate will be presented to the Region 3 Council at its meeting on October 19th.

The Nominating Committee recommended that Carl Casteel be appointed to serve the unexpired term for Karl Stauber. Mr. Casteel is the President and CEO of the Danville Regional Foundation and stated he looks forward to serving on the Region 3 Council. He will be representing the non-profit council membership category. Scott Burnett made a motion that Carl Casteel be appointed to serve the unexpired term for Karl Stauber; the motion was seconded by Charles Majors and was approved by unanimous vote.

Other New Business

Jeff Reed resigned via email just prior to the July meeting. The Nominating Committee will begin identifying a replacement.

Program Director's Report

• The GO Virginia Region 3 Council has in-place service agreements with the Southside Planning District Commission (SPDC) and UVA's Weldon Cooper Center for Public Service (Cooper Center). The Executive Committee approved the SPDC support services agreement for FY22-23 and the Cooper Center agreements for FY22-23 and FY23-24 at its meeting on June 22nd. Regarding the

Cooper Center's support service agreement, the GO Virginia Region 3 Council approved a budget amendment to fund this agreement for FY22-23 at its meeting on April 20th.

- The SPDC issued a Request for Proposals (RFP) on May 31st for communications and media services for the GO Virginia Region 3 Council, following State procurement protocols. There was one response to the RFP which came from the current contract holder, LetterPress Communications. The Communications Committee Chair, the SPDC Executive Director, and the Region 3 Executive Director reviewed the proposal and approved the issuance of a contract with LetterPress Communications. The new services agreement will have an annual term with two one-year extensions for a total of three years. The SPDC Executive Director will execute the contract on behalf of the Region 3 Council, which is customary in these matters.
- The 2022 All Hands Meeting was held at The Prizery in South Boston on May 5th, with just over 100 people attending. Presenters gave attendees an overview of projects and areas of interest the GO Virginia Region 3 Council has supported over the last several years, including:
 - Growth & Diversification Plan 2021 Update
 - Entrepreneurship Innovation and Investment Strategy SOVA Rise Collaborative
 - Great Opportunities in Technology and Engineering Careers (GO TEC) Institute for Advanced Learning and Research
 - Bridge to Recovery Southern Virginia Regional Alliance and Virginia's Growth Alliance
 - Community Leadership Dr. Larry Terry, Executive Director, Weldon Cooper Center for Public Service

These general ideas will be further researched and refined under the guidance of the Executive Committee.

- The following highlights of the FY22-23 GO Virginia State budget were presented:
 - Base funding statewide has been held steady at \$30M
 - Unchanged amounts statewide for support organizations (\$2.250M), regional per capita pool (\$16.90M), and statewide competitive pool (\$10.85M)
 - Transfer of \$27.516M from the GO Virginia fund to the General Fund for unobligated funds from FY19, FY20, FY21, and the Economic Recovery and Resilience Program
 - Outlines a new one-time allocation of \$2.25M to the GO Virginia Talent Pathways Planning; DHCD will administer these funds in partnership with Virginia Economic Development Partnership
 - Allows the GO Virginia State Board to rescind unobligated per capita funds allocated to each regional council if the unobligated balance exceeds its average annual per capita distribution; all rescinded funds would be made available in the statewide competitive pool
 - Additional reporting requirements for DHCD to executive and legislative branches

Additionally, the General Assembly's adopted budget recaptured unexpended funds totaling \$27,515,896 from the GO Virginia program. These funds have accumulated over the last several years within individual regions. Region 3 holds no balance of unexpended funds for any prior fiscal year; thereby, no Region 3 grant funds were recaptured.

• The 2022 Virginia General Assembly approved, and Governor Youngkin signed, amendments allowing advisory public bodies to meet electronically under circumstances if a quorum is not physically present at the meeting place. These amendments will apply to the Region 3 Council and the Executive Committee when it becomes effective on September 1st. Staff will develop a draft plan for electronic meetings held by the Council and Executive Committee. This draft plan will be presented to the Executive Committee at its meeting on August 17th and the Region 3 Council at its meeting on October 19th.

Executive Summary

This GO Virginia Region 3 Entrepreneurship & Innovation Investment Strategy positions Southern Virginia as a national model for rural entrepreneurship development. This dynamic strategy connects and enhances the **entrepreneurship ecosystem** which is the infrastructure necessary to help entrepreneurs thrive.

Entrepreneurship includes all sizes and types of ventures. **Innovation** is a subset of entrepreneurship representing ventures that bring "a new method, idea, product, etc." to market.

Rural entrepreneurship development has unique characteristics, challenges, and opportunities versus entrepreneurship development in metropolitan cities or areas with immediate access to university research capabilities, federal labs, and density of population and networks. Region 3's greatest opportunity is to connect its existing assets and take a unified approach to building partnerships with resources outside of the region.

This report was developed through a transparent process in which the project partners facilitated in-person and online community engagement sessions. This input guided additional research including national best practices, leading to identification of the recommended strategies, actions and outcomes that are feasible and relevant for Region 3.

This report includes three key deliverables:

1. Map of the Entrepreneurial Ecosystem (SOVA Entrepreneurs Resource Hub)

The SOVA Entrepreneurs Resource Hub is an online resource directory powered by Startup Space, a cloud-based ecosystem management software. This tool is a living database of local, regional, state, and national resources that can be filtered by location, industry, or type of service the entrepreneur needs. By providing a free-to-use, publicly available directory of resources, this online tool will help entrepreneurs connect to the right people and find the resources they need faster than ever before. SOVA Entrepreneurs Resource Hub can be embedded on the websites of any resource provider to maximize availability for entreprenuers throughout the region.

2. Map of Existing Businesses (R3B Map)

The Region 3 Business Map ("R3B Map") is a set of evergreen, functional tools, including a comprehensive, searchable database and ArcGIS visual maps. The database integrates timely, credible data from JobsEQ and ReferenceUSA/InfoSource. The R3B Map can be used by regional economic developers and Planning District Commissions to support enhanced Business Retention and Expansion (BRE) programs by identifying supply chain opportunities and increasing intraregional trade. The R3B Map components need to be maintained and updated regularly. Training should be provided to end users to maximize usefulness.

3. Investment Strategy

The investment strategy is intended to provide actionable strategies to guide a potential investor (i.e. GO Virginia) to fund entrepreneurship, innovation, and ecosystem development. This dynamic strategy identifies six key opportunities intended to be implemented comprehensively.

GO Virginia Region 3 Entrepreneurship & Innovation Investment Strategy

Final Draft 10/30/20

The six investment opportunities are:

- 1. Connect entrepreneurship resources by leveraging the investment in the digital SOVA Entrepreneurs Resource Hub and by convening regional ecosystem builders on a regular basis for professional training, action-oriented work groups, and adoption of a transparent regional entrepreneurship scorecard. This group would leverage connections to create a region-wide mentor network.
- 2. Support existing business growth and innovation by leveraging the investment in the R3B Map and by formalizing referral pipelines among economic development partners to develop a robust business retention and expansion (BRE) program.
- 3. Develop entrepreneurship training programs to nurture aspiring entrepreneurs. Specific actions include creation of a region wide youth entrepreneurship program and a training pipeline for adult learners that has levels to meet entrepreneurs where they are in the process of business creation, expansion, or commercialization. Training programs should be designed to serve underrepresented populations. Training programs should prioritize product and technology business development, with specific programming aligned with Region 3's target sectors.
- **4. Expand access to capital** by facilitating a regional angel investor network (not a fund), creating a region-wide revolving loan fund, and engaging traditional lenders in a community development fund.
- **5. Expedite broadband expansion** by funding middle mile expansion projects that support the regional growth and diversification plan and by facilitating local and regional efforts that will build leadership capacity to partner with ISPs and successfully obtain federal and state grants for last mile efforts.
- **6. Fund a Regional Entrepreneurship Navigator to facilitate implementation.** This individual would be focused on convening regional ecosystem builders and scaling the regional ecosystem by facilitating communication and collaboration among support providers.

For successful implementation of this strategy, collaboration is essential - and the time to start is now. Especially with the rural nature of the Southern Virginia region, sharing resources and creating synergies wherever possible is necessary to scale the regional ecosystem, leverage supply chain opportunities, and maximize support for entrepreneurs. Given the onset of the coronavirus pandemic in early 2020, the time for innovative strategy development and deployment is now! Region 3 is home to talented ecosystem builders who are ready to engage and get to work.

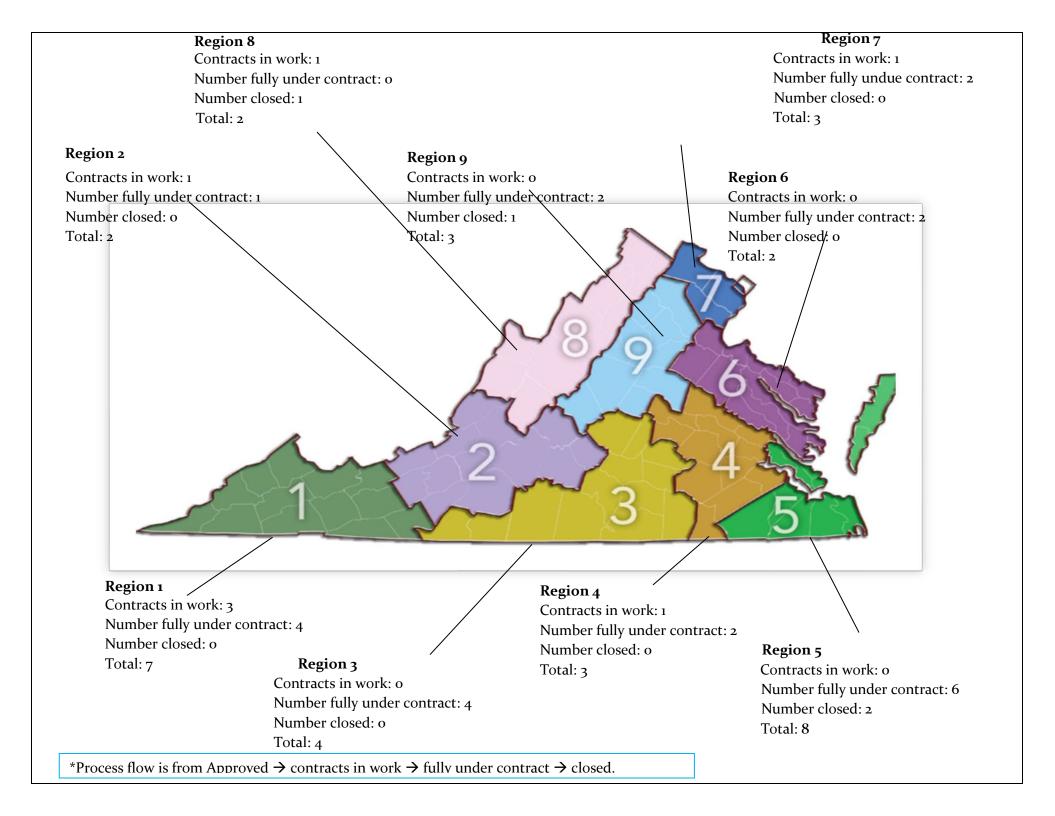

Schedule

The Region 3 Council adopted Policy #9 on October 20, 2021. This policy provides the conditions and procedures for Region 3 Council members to participate, under certain conditions, at public meetings through electronic communication means from remote locations. Attached is a copy of the policy.

Recently, the Virginia Freedom of Information Advisory Council prepared guidance on how public advisory bodies (generally non-elected or local government-appointed) could conduct all-virtual regular meetings. This guidance was responsive to amendments made by the 2022 General Assembly to the Virginia Freedom of Information Act.

Based on the FOIA amendments and the Advisory Council's guidance, GO Virginia Regional Councils qualify to have all virtual meetings no more than two (2) times per calendar year of twenty-five percent (25%) of the meetings held per calendar year. Additionally, several procedural steps need to be satisfied to hold all-virtual meetings, i.e., public notice with virtual meeting instructions, allowing public access and participation, and other related matters.

The Region 3 Council held all-virtual meetings during the Governor's declared state of emergency for the pandemic. The GO Virginia Region 3 staff's experience holding all-virtual meetings can be used again in light of new legislation.

In light of the preceding, the Executive Committee and staff recommend to the Region 3 Council the following provisions be added to Policy #9 to implement all-virtual meetings:

- The Region 3 Council may conduct all-virtual meetings in accordance with subsection C of §2.2-3708.3.1-9 (Meetings held through electronic communication means; situations other than declared states of emergency) of the Code of Virginia, as amended.
- ii. The Region 3 Council will designate at its last quarterly meeting of the calendar year the schedule for virtual and in-person meetings for the next calendar year for planning purposes.

The following is the Region 3 Council proposed meeting schedule for 2023 based on the Policy #9 amendment:

- January 18, 2023 (virtual)
- April 19, 2023 (in-person_SOVA Innovation Hub)
- July 19, 2023 (virtual)
- October 18, 2023 (in-person_SOVA Innovation Hub)

It should be noted that the Region 3 Council will formally adopt its annual meeting schedule for 2023 as part of the January 18th meeting, which is in keeping with past practice.

The all-virtual meeting option is available to the Executive Committee for its meetings. These meetings are held as needed during months when the Region 3 Council is not meeting. The Executive Committee will set a virtual meeting schedule when it meets next.

RECOMMENDATION:

Adopt Region 3 Council Policy #9 amendments as presented and approve the proposed 2023 schedule for virtual and in-person meetings.

REGION 3 COUNCIL POLICY #9

TITLE: MEMBERS PARTICIPATING BY ELECTRONIC MEANS

EFFECTIVE DATE: October 20, 2021

POLICY STATEMENT:

The GO Virginia Region 3 Council is subject to the provisions of §23.1-3107 of the Code of Virginia, as amended. This code section provides the conditions and procedures for Region 3 Council members to participate, under certain conditions, at public meetings through electronic communication means from remote locations.

POLICY:

- I. The Region 3 Council, Executive Committee, or a Council Committee may permit a member to attend a meeting through electronic communication means under the following circumstances and provided that the Council member has notified the Chair of the Council, Executive Committee, or Council Committee on or before the day of a meeting that they are unable to attend the meeting due to:
 - i. a temporary or permanent disability or other medical condition that prevents the member's physical attendance;
 - ii. a family member's medical condition that requires the member to provide care for such family member, thereby preventing the member's physical attendance; or,
 - iii. a personal matter that prevents the member's physical attendance. If a member cannot attend the meeting due to a personal matter, the member must identify with specificity the nature of the personal matter.
- II. The Region 3 Council, Executive Committee, or a Council Committee may also permit a member to attend a meeting through electronic communication means if, on the day of the meeting, a member notifies the chair that such member's principal residence is more than sixty (60) miles from the meeting location identified in the required notice for such meeting.
- III. A quorum of the Council, Executive Committee, or Council Committee must be physically assembled at the meeting location identified in the required notice for such meeting.
- IV. A majority of the Council, Executive Committee, or Council Committee members present must vote to approve the absent member's participation in the meeting; however, the decision shall be based solely on the criteria in this policy, without regard to the identity of the member or matters that will be considered or voted on during the meeting. If the absent member's remote participation is disapproved because such participation would violate this policy, such disapproval shall be recorded in the meeting minutes with specificity.



V. If participation by a Council member through electronic communication means is approved by an affirmative vote of the Region 3 Council, Executive Committee, or a Council Committee pursuant to Section 1 or 2 above, the meeting minutes shall reflect the remote location from which the member participated; however, the remote location need not be open to the public.

The minutes shall also reflect that the member participated through electronic communication means due to:

- i. a temporary or permanent disability or other medical condition that prevented the member's physical attendance;
- ii. a family member's medical condition that required the member to provide care for such family member, thereby preventing the member's physical attendance;
- iii. a personal matter that prevents the member's physical attendance and the nature of the personal matter is to be include in the meeting minutes with specificity; or,
- iv. the member's principal residence is more than 60 miles from the meeting location; or (iv) a personal matter.

If the absent member's remote participation is disapproved because such participation would violate any part of this policy, such disapproval shall be recorded in the Board's or Committee's minutes with specificity.

- VI. Participation by the absent member due to a personal matter shall be limited in each calendar year to two (2) meetings or 25 percent (25%) of the meetings of the Council, Executive Committee, or Council Committee to which the member belongs rounded up to the next whole number, whichever is greater.
- VII. The Council, Executive Committee, or Council Committee will make arrangements for the voice of the absent member to be heard by all persons in attendance at the primary or central meeting location.
- VIII. This policy shall be applied strictly and uniformly, without exception, to the entire membership and without regard to the identity of the member requesting remote participation or the matters that will be considered or voted on at the meeting.

APPROVAL AND REVIEW: This Council policy was reviewed and approved on October 20, 2021.

SUPERSESSION: This Council policy is new.
