Agenda Amendment

Chair Willis requested an amendment to the agenda to move Committee Reports to the first order of business. Melody Foster made a motion to amend the agenda; the motion was seconded by Robert Bates and approved unanimously by roll call vote.

Committee Reports

The Nominating Committee reported that Clark Casteel, President/CEO, Danville Regional Foundation; Melody Foster retired Executive Director, Commonwealth Regional Council and Rhonda Hodges, Principal and Owner, Hodges Workwise, LLC have each agreed to a four-year reappointment to the Region 3 Council with a term beginning July 1, 2025 and ending June 30, 2030. Additionally, Delegate Danny Marshall House District 49- Danville City, Pittsylvania County, and Halifax County; Sheri McGuire, Associate Vice President for Community and Economic Development, Longwood University; and Angie Kellett, Director of Economic Development, Mecklenburg County have each agreed to serve on the Region 3 Council for a four-year term beginning July 1, 2025 and ending June 30, 2030. Randy Lail made a motion to appoint/reappoint the Council members as recommended by the Nominating Committee; the motion was seconded by Amy Griffin and approved unanimously by roll call vote.

Chair Willis appointed herself, Randy Lail, Robert Bates, Amy Griffin, and Elizabeth Leggett to the Executive Committee. She also appointed herself and Randy Lail to both the Personnel and Nominating Committees, noting an additional Executive Committee member will be added to each. Special purpose committees will be appointed as needed. Chair Willis asked members for questions or comments; there being none, there was no discussion regarding committee appointments.

Approval of Minutes

Chair Willis noted that the minutes of the April 16, 2025 Full Council meeting were received via email prior to the meeting and included in the meeting packet. Melody Foster made a motion that the minutes from the April 16, 2025 Full Council meeting be approved as presented; the motion was seconded by Keith Harkins and approved unanimously by roll call vote. Ilsa Loeser abstained as she was not present at the April meeting.

Financial Reports & Project Update

Bryan David and Deborah Gosney presented the Financial Reports and Project Updates that were included in the meeting packet for the period ending June 30, 2025. Randy Lail made a motion that the Financial Reports be approved as presented; the motion was seconded by Elizabeth Leggett and approved unanimously by roll call vote.

SPECIAL APPEARANCES & PRESENTATIONS

<u>LetterPress Communications Presentation</u>

Alex Veatch, Chief Operating Officer, LetterPress Communications, presented the FY25 (7/1/2024 – 6/30/2025) Region 3 Annual Communications Report.

SOVA Partnership for Health Science Careers Presentation

Cynthia Lawrence, Executive Director, Blue Ridge Partnership for Health Science Careers and Dr. Carrie Sutter, Co-Director Center for Health Workforce, George Mason University presented the final report for the Southern Virginia Partnership for Health Science Careers which was funded by a Region 3 Talent Pathway Initiatives (TPI) planning grant.

Co-locating Data Centers and CEA Greenhouses Presentation

Derek Smith, Executive Director, and Rob Eddy, Resource Efficiency Horticulturist, Resource Innovation Institute presented the Co-locating Data Centers and CEA Greenhouses Feasibility Report which was funded by a Region 3 per capita planning grant.

OLD BUSINESS

Project Pipeline

Bryan David reviewed the current project pipeline which was emailed to Council members prior to the meeting. The following projects were discussed:

- SOVA Partnership for Health Science Careers: This project will implement the plan developed through the SOVA Health Sciences TPI Planning grant. The project will support a staff position to facilitate data collection, data analysis, and healthcare workforce development.
- Industrial Skilled Trades Training Program: This project will support the creation of a
 workforce development training program for industrial skilled trades focusing on Region 3's
 targeted sectors. Project partners will include Patrick & Henry, Danville, and Southside
 Virginia Community Colleges.
- CEA Innovation Center Research Building Expansion: This will be an implementation project for the CEA Strategy & Roadmap which will involve installing a prefabricated research

- greenhouse, making associated building improvements, and preparing the site and utilities.
- Blue Ridge Innovation Corridor (BRIC): BRIC is an initiative to establish Virginia's first inter-regional economic zone focusing on advanced manufacturing and biotechnology. This planning project will establish a comprehensive framework for transforming the BRIC corridor into a globally competitive innovation ecosystem spanning across GO Virginia Regions 2 & 3.
- Region 3 Leadership Development Project: This project will be in partnership with the UVA Sorenson Institute for Leadership and the Virginia Institute for Government to develop a community leadership program in Region 3.

Chair Willis asked members for questions or comments; there being none, there was no discussion regarding the updates.

NEW BUSINESS

Project Approval

GOVA Region 4 staff has received a site development planning application from Virginia's Gateway Region (regional economic development organization) for a routine regional site development planning grant for all of its member localities to identify and prioritize new sites suitable for public sector industrial park development. As of July 1st, Brunswick County, along with Greensville County and Emporia, are members of this regional economic development organization. Based on past practice involving Region 3 and Region 4 localities, Region 3 has been asked to contribute one-ninth of the \$100,000 planning grant request on behalf of Brunswick County totaling \$11,111. Randy Lail made a motion to approve the application as presented; the motion was seconded by Ilsa Loser and approved unanimously by roll call vote. Alfreda Reynolds abstained citing a conflict of interest.

Policy Update

A requirement of the code provision (§2.2-3708.3, Code of Virginia) requires each GOVA Region Council to readopt its electronic meeting policy annually. Elizabeth Leggett made a motion to adopt the policy as presented; the motion was seconded by Melody Foster and approved unanimously by roll call vote.

PROGRAM DIRECTOR'S REPORT

Bryan David presented the Program Director's Report as detailed in the meeting packet. The topics discussed were the status of the SOVA Fab Lab Project, the SVCC Occupational Training Facility Project, the G&D Plan Update, the GOVA Regional Council Committee Report, and upcoming Region 3 staff transition.

The Executive Committee entered into closed session for the discussion of upcoming personnel changes. Randy Lail made the motion that pursuant to Section §2.2-3711 of the Virginia Freedom of Information Act, the GO Virginia Region 3 Council convene in closed session to discuss Region 3 staffing transitions; the motion was seconded by Melody Foster and approved by roll call vote.

Upon return to open session, Randy Lail made the motion that having convened and concluded a closed meeting pursuant to Section §2.2-3711 of the Virginia Freedom of Information Act on this

date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act; and per Section §2.2-3712(D) of the Code of Virginia to certify that the executive meeting was conducted in conformity with Virginia law; and that the GO Virginia Region 3 Council hereby certified that to the best of each member's knowledge;

- 1) Only public business matters lawfully exempted from open meeting requirements by Virginia Law were discussed in the executive meeting to which certification resolution applies, and;
- 2) Only such business matters as were identified in the motion convening the executive meeting were heard, discussed, or considered by the Council; the motion was seconded by Melody Foster and approved by roll call vote. No formal action was taken upon return to open session.

Status: GOVA funds are 81% expended. The facility remains in soft opening mode. Currently, they are engaging as many students and community members as possible, and launching the community membership plans in manageable blocks. The electrical upgrade needed to operationalize the heavy makerspace has been completed. The dust collection systems are the last remaining installations to make full use of the heavy duty makerspace. To date, 121 prototypes have been built, 740 people have used the facility, and 69 tours/events have been held engaging a total of 384 individuals. A community grand opening will be held in early 2026 allowing for time to finalize the community engagement aspects of the project.

Status: GOVA funds are 49% expended. A project extension request is in process. MBC construction continues and is accelerating fiber builds between Stony Creek and Farmville and Louisa. These routes are anticipated to be completed by summer of 2026. Active economic development prospects continue to drive acceleration of the completion timelines. MBC anticipates having all 130+ miles of new middle mile fiber completed by summer of 2027, if not earlier.



RE: Project Pipeline Report

Below is information about projects that are in varying stages of development:

I. SOVA Partnership Health Science Careers

-the Talent Pathways Initiative planning project was completed by the project principals with the Blue Ridge Partnership for Health Science Careers (C. Lawrence) and George Mason University (Dr. C. Sutter). Dr. Julie Brown (IALR) has provided in-region leadership and staffing support to the SOVA Partnership. This report was presented to the Region 3 Council at its meeting on July 16th.

-the SOVA Partnership group met virtually on September 12th. The meeting involved finalizing the data work, received an update on the development of similar healthcare workforce development partnerships elsewhere in Virginia, and next steps to solicit interest to identify a lead organization to apply for a Region 3 Per Capita grant that would operationalize the SOVA Partnership.

-The Executive Committee was briefed on this matter at its meeting on September 17th and authorized the issuance of a *Request for Letters of Interest* from an organization to serve as the lead organization. The results of the request will be presented to the Region 3 Council at its meeting on October 15th.

II. Industrial Skilled Trades Training Program

- -a Region 3 Per Capita implementation grant would create a workforce training program for "industrial skilled trades" to meet student demand beyond current offerings at each of the community colleges.
- -the application was prepared and submitted by Patrick and Henry Community College in partnership with Danville Community College and Southside Virginia Community College for consideration by the Region 3 Council at its meeting on October 15th.

III. CEA Innovation Center Research Building Expansion

- -Dr. Scott Lowman has shown that the greenhouses currently used for contract research for CEA firms and other academic institutions are at capacity, creating a backlog of work. Contract research is an operating revenue source for the CEA Innovation Center.
- -the project would involve installing a prefabricated research greenhouse, making associated building improvements, and preparing the site and utilities.

- -a grant from the Southern Crescent Regional Commission (SCRC) was submitted following approval of a pre-application for the project. Approval is anticipated in the coming weeks.
- -a Tobacco Region Revitalization Commission will be pursued to support the purchase of the greenhouse and fund the associated site development and utilities.
- -a GO Virginia Region 3 Per Capita grant would be pursued for the equipment used in research at the greenhouse for a funding request of approximately \$250-\$500k—submission for January 2026 Region 3 Council meeting.

IV. Blue Ridge Innovation Corridor (BRIC)

- -the <u>Blue Ridge Innovation Corridor</u> is an initiative of leaders from business, education, non-profits, and the public sector to establish Virginia's first inter-regional economic zone, specifically designed to capture the convergence of advanced manufacturing and biotechnology in the 21st-century economy.
- -this project is in partnership with GO Virginia Region 2.
- -the application was prepared and submitted by a consulting firm, S.I.R., on behalf of the BRIC organization for consideration by the Region 3 Council at its meeting on October 15th.
- -the Region 2 Council will consider the application at its meeting on October 29th.

V. <u>Virginia Tech – Additive Manufacturing and Advanced Materials (AM2) Tech Hub</u>

- -launched in 2023 with a grant by the US EDA, the AM2 Tech Hub is creating a competitive advantage for advanced manufacturing and advanced materials in Region 2 and Region 3.
- -This initiative is managed by Virginia Tech's Center for Economic and Community Engagement and includes businesses in Regions 2 and 3, Virginia Tech, and the Center for Advanced Learning and Research.
- -the proposed project would build on the Tech Hub and create:
 - Building AM2 Innovation Studios in Blacksburg and Danville
 - Embedding AM2 Innovation Fellows
 - Learning AM2 Career Network to enhance education and training at all levels
- -the budget will be determined as part of the application submission in early 2026.

-this would be a statewide competitive grant, and no Region 3 Per Capita funds would be used.

VI. <u>Virginia's Heartland Regional Economic Development Alliance</u>

- -after meeting with the Heartland Alliance's Executive Director, Alex McCoy, there is an opportunity (Phase 1) for a business site planning project to determine the inventory available business investment sites and buildings in the region, each's VEDP tier level, and analysis of the opportunities for up-tiering the regional priority properties.
- -Phase I would include a facilitator to support the members in understanding the findings from the engineering analysis and how best to set priorities and timing of site investments.
- -Phase II could be an identification and analysis of potential large sites that could be developed by a regional industrial development authority, by members of the Heartland Alliance, which could include exploring the potential to reorganize and repurpose the Heartland Regional Industrial Development Facilities Authority.
- -all future applications submitted by the Heartland Alliance are subject to receiving its non-profit organization tax exemption by the IRS and Amelia County becoming a full member.
- -a project budget for Phase I is estimated at \$100k.

VII. <u>Farm Park Siting, Fiscal and Economic Impact, and Workforce Development</u> Project

- -this project will be a planning project building upon the recent feasibility report on the colocation of data centers and CEA greenhouses prepared by Resource Innovation Institute.
- -the planning project will include, but not be limited to, the following elements in collaboration with regional and local economic developers:
- siting requirement matrix and other related items.
- scoping analysis and ranking of potential sites which may be most suitable for a Farm Park.
- development and research of a Farm Park's fiscal (direct/indirect local, regional, and state tax revenues) and economic impact (direct, indirect, and induced local, regional, and state economic activity and job creation).
- a project budget is under development.

VIII. Virginia Al Innovation Hub & Venture Studios

-the Smart Innovation Corporation (non-profit) is proposing to develop an industryaligned workforce development program to support individuals pursuing careers in artificial intelligence, data analytics, and applied machine learning, and to support employees of existing businesses in the use of AI in the workplace.

Additionally, the program would incorporate training for local, state and federal government employees in the use of AI in the workplace.

- -the project principals have experience and credentials in the area of technology workforce development. One of the principals was raised in Halifax County.
- -the project principals have met with the Region 7 Program Director, and she has expressed interest. A follow-up meeting between Region 7 and Region 3 Program Directors will occur.
- -the project principals were awarded and successfully implemented a GO Virginia workforce development grant from Region 7 involving cybersecurity.
- -this would be a multi-region project for GO Virginia Region 3 (Southern Virginia) and GO Virginia Region 7 (Northern Virginia).
- -project concept, budget, schedule, and deliverables under development with SIC principals.
- -the concept will be further development once the Virginia State Chamber of Commerce's Blueprint Virginia 2035 is released in December 2023, which includes the GO Virginia Regions 3 and 2 funded *AI in the Workplace Component* project.

The Project Review Committee will meet on Friday, October 10th, to review the following project applications:

- I. <u>Danville Aviation Training Facility</u> The project involves the installation of data network furnishings and equipment for the 13,244 sq. ft. Aviation Training Facility being constructed at Danville Regional Airport. This facility will host Averett University's Aeronautics program, Danville Community College's aviation maintenance technology training program, and the new Danville City Schools' Aviation Science Pathways, which is linked to Danville Community College's program.

\$ 138,000 Total Project Budget

- A project summary and the complete application will be distributed to the Region 3 Council under separate cover with the Project Review Committee's recommendation.
- II. <u>Blue Ridge Innovation Corridor (BRIC)</u> This is a business-led initiative, extends from Roanoke to Blacksburg through Martinsville, Danville, and the counties in between. Currently, it is Virginia's fourth-largest economic region and its second-fastest-growing economy, relative to Northern Virginia, Richmond, and Hampton Roads.

This planning project will retain a qualified consultant to prepare the following deliverables:

- Three sector strategies for Advanced Manufacturing, Life Sciences & Biotechnology, and National Security & Defense Innovation.
- Non-Engineering investment strategy for business sites, broadband, energy, transportation, and workforce housing.
- Funding and financing roadmap strategy to align federal, state, philanthropic, and private capital funding.

Region 3 Industrial Skilled Trades Regional Expansion Patrick & Henry Community College (P&HCC), Danville Community College (DCC), and Southside Virginia Community College (SVCC) are working collaboratively to grow a strategic talent pipeline to attract new companies and grow existing Region 3 traded-sector businesses through a targeted industry-skilled trades workforce development program.
 - Across Region 3, employer demand for workers trained to fill industrial skilled trades positions
 has grown exponentially in recent years, as has enrollment at each school. To meet this
 demand, all three schools are working to expand existing training. Virginia Career Works West
 Piedmont Region will also serve as a project partner to assist with the job placement of
 students.
 - The partner colleges will expand and scale training in carpentry, HVAC, plumbing, powerline workers, and industrial maintenance. This training will result in industry-accepted certifications that are in demand by Region 3's traded-sector businesses.
 - Industrial skilled trades (machinery maintenance and repair, plumbers, pipefitters, steamfitters, plumbing technology, carpentry, trades supervisors, and electricians) have an average annual salary of \$55,850.
 - The project would be funded from GO Virginia Region 3's Per Capita fund as an implementation grant for workforce development and from the GO Virginia Statewide Competitive fund.
 - The current unobligated balance of the FY2025-2026 Region 3 Per Capita fund (9.17.25) is \$1.1MM. Accounting for the pending grant for the Danville Aviation Training Facility (\$92,000), the remaining FY2025-2026 Per Capita fund balance of \$1.108MM is available.
 - The remaining balance for this project of \$213,786 will be funded by the GO Virginia Statewide Competitive fund (<~10MM balance available). The GO Virginia State Board expanded the Statewide Competitive in December 2023 beyond multi-region projects so that "...a single region may apply for implementation projects through the Competitive Fund if their funding request exceeds their available Per Capita Fund balance."

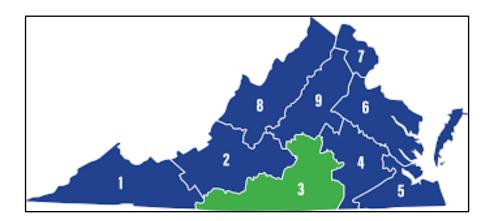

I: Introduction

Region 3, located in rural south-central Virginia, covers the largest land area yet has the smallest population of the nine GO Virginia (GOVA) regions. The region is comprised of thirteen counties and two cities. While predominantly rural, Region 3 holds significant opportunity: it is home to established hubs of advanced manufacturing and technology, growing innovation assets that support an entrepreneurial ecosystem, higher education institutions committed to workforce development, abundant natural resources, and civic leadership that provides the social capital needed to adapt to shifting market demands.

Region 3 is also the only GOVA region that has consistently expended its full per capita allocation each year, a clear indicator of the strength and success of its initiatives. The FY25 Annual Report will incorporate updates to the Growth & Diversification Plan, highlight ongoing projects and regional partners, assess the impacts of funded initiatives, and review both outreach efforts and the current project pipeline.

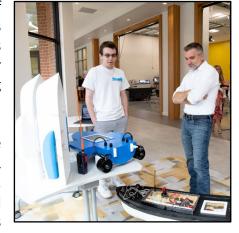
II: Growth & Diversification Plan

The initial development of Region 3's Growth & Diversification (G&D) Plan was an extensive process designed to establish a strong foundation for future projects and initiatives. Nearly 100 strategically selected stakeholders participated in engagement sessions, which included five virtual group discussions focused on entrepreneurship, business retention and scale-up, sites, and talent. Additional one-on-one and group interviews engaged a wide range of participants, including chambers of commerce, educational institutions, community foundations, youth leaders, grant recipients, economic developers, local government managers, state agencies, innovation catalysts, and business leaders. From this process, Region 3 identified its initial Priority Targeted Industry Sectors: Business Services; Agriculture & Food Processing; Energy, Natural Resources, & Finished Products; Health Care Services; Information Technology & Communication Services; and Advanced Manufacturing & Advanced Materials.

The 2023 Review of Region 3's G&D Plan provided a more streamlined assessment of the 2021 update, focusing on evaluating progress and identifying meaningful adjustments to guide future initiatives. Input was gathered from existing project partners, an ad hoc work group of Region 3 Council members, and Region 3 staff. The Longwood Small Business Development Center contributed data analysis, including employment and wage trends, economic development announcements, SWOT analyses of targeted sectors, workforce gaps, and recommendations for broadening the sectors of focus. The 2023 G&D Plan Review, approved by both the Region 3 Council and State Board, resulted in several key updates: the expansion of targeted industry sectors, the addition of Controlled Environment Agriculture as a new sector, and a renewed emphasis on building leadership capacity within the Council and across the Region.

Currently, Region 3 is engaged in another comprehensive update of the G&D Plan, which will be finalized during the first of FY26. This update builds on the lessons learned from earlier iterations, combines new economic and workforce data analysis with broad stakeholder input, and ensures that the Plan continues to reflect the evolving opportunities and challenges facing the Region.

In FY25, the Region 3 economy remained largely consistent with the trends and metrics outlined in the 2021 and 2023 Growth & Diversification Plans. What has become increasingly evident, however, is the strategic nature of the Region 3 Council's investments. Approved projects have been intentionally designed to build capacity across



multiple targeted sectors, with many initiatives supporting more than one priority area simultaneously. Since the inception of GO Virginia Region 3, a total of 32 projects have been awarded, representing more than \$22 million in funding. These investments have been further leveraged with just over \$22 million in local and private matching funds, amplifying their impact. Of the approved projects, 54% have advanced talent evolution, 33% have supported site development, 11% have strengthened the entrepreneurial ecosystem, and 2% have contributed to cluster scale-up.

These outcomes have served as a critical foundation for the 2025 Growth & Diversification Plan update, ensuring that future priorities build upon proven successes while addressing emerging opportunities across the region. 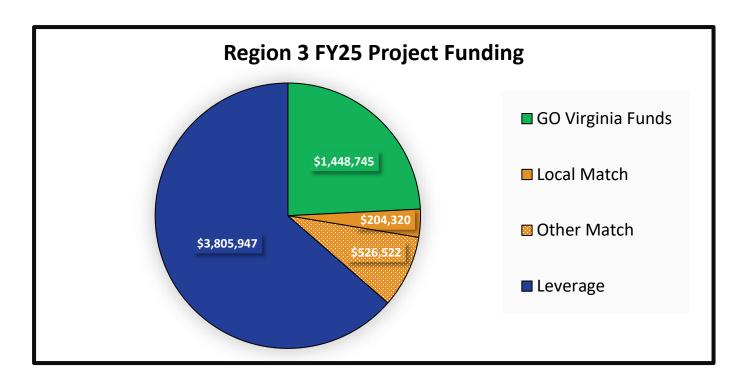

IV: Regional Collaboration & Partner Support

Region 3's strength lies in its proven ability to foster meaningful collaboration that advances statewide priorities. In FY25, Region 3 partnered with Region 2 to champion the inclusion of an Artificial Intelligence (AI) Statewide Assessment in the 2025 *Blueprint Virginia*, demonstrating leadership in addressing emerging workforce trends. This joint initiative, conducted in coordination with the Virginia Chamber of Commerce, collects real-time insights from business and workforce leaders through surveys and interviews, assessing AI's current and future impact on Virginia's key industries. The resulting comprehensive report will analyze AI applications in the workplace, standardize terminology, and evaluate workforce readiness across all nine GO Virginia regions. It will also catalog existing workforce development programs, identify gaps in AI skill integration, and offer strategic recommendations for aligning K-12, higher education, and regional workforce programs with future AI demands. Through this collaborative effort, Region 3 continues to exemplify how regional partnerships can drive innovation and strengthen Virginia's economic competitiveness.

Region 3's strength in collaboration is further demonstrated through its leadership of the GO TEC (Great Opportunities in Technology and Engineering Careers) initiative, one of the most successful multiregional workforce development projects in Virginia. Originating in Region 3 and led in partnership with the Institute for Advanced Learning and Research (IALR), GO TEC was designed to build a strategic talent pipeline to attract new companies and support the growth of existing businesses in key traded sectors. Through Region 3's vision and coordination, the program expanded to include GO Virginia Regions 1, 2, 4, and 5, creating a unified, statewide framework that connects K–12 schools, higher education, economic developers, and industry partners. What began as a regional pilot has evolved into a national model for aligning education and industry needs, with GO TEC career labs and training pathways now preparing students across the Commonwealth for high-demand, high-wage jobs. Region 3's leadership and early investment served as the catalyst for this transformative, collaborative workforce initiative.

V: Outcomes & Impact

In FY25, GO Virginia Region 3 demonstrated exceptional leadership and collaboration in advancing key initiatives that will have a lasting impact on the region's economy and workforce. One of the most significant accomplishments was Region 3's success in leading the statewide effort to make healthcare projects eligible for GO Virginia funding. For years, Region 3 had identified healthcare services and workforce development as critical priorities due to the region's limited access to providers and the sector's direct impact on economic competitiveness. After extensive advocacy, data analysis, and collaboration with state partners, the GO Virginia State Board adopted Policy #17 in June 2024. This policy officially made healthcare projects eligible for GO Virginia grants under specific conditions, such as those already present in Region 3. This policy shift originated from Region 3's persistent efforts, beginning with its \$135,000 planning grant for the Southern Virginia Partnership for Health Science Careers, matched by the Claude Moore Charitable Foundation. This milestone not only benefits Region 3 but also establishes a precedent for other regions to address healthcare workforce shortages through GO Virginia-supported initiatives.



Region 3 also took major steps toward strengthening leadership across the region through its Envisioning Leadership initiative. Recognizing that leadership capacity is foundational to regional collaboration and economic development, the Region 3 Council partnered with Virginia Tech's Center for Economic and Community Engagement and Virginia Cooperative Extension to conduct the 2024 Spring "Advance" in South Boston. This event brought together 30 leaders representing all subregions to identify leadership assets, discuss strategies for building stronger regional networks, and

develop actionable next steps for fostering leadership pipelines. The session emphasized sustaining strong Council and regional leadership, increasing stakeholder engagement, and supporting sustainable regional economic development organizations (REDOs). The resulting report identified immediate next steps, including mapping leadership development assets, cultivating new regional champions, and aligning leadership development with economic diversification goals. Leadership advancement efforts will ensure that Region 3 continues to grow both its social and economic capital.

In addition, Region 3 included Transportation & Logistics as a new targeted traded sector in its Growth & Diversification (G&D) Plan because of a growing industry demand. This strategic amendment, recommended by DHCD GO Virginia staff and adopted by the Region 3 Council, ensures that projects like the expansion of Southside Virginia Community College's Occupational Training Facility to support their Truck Training Program are eligible for GO Virginia Per Capita funding. This addition recognizes the critical role logistics and supply chain management play in supporting advanced manufacturing and regional commerce, especially in rural areas where connectivity to markets is essential.



Finally, Region 3 launched the 2025 Growth & Diversification Plan update process, which began in February 2025 and will conclude in October 2025. The Advisory Committee, composed of Region 3 Council members, regional leaders and subject matter experts, convened multiple times to analyze economic and workforce data. Stakeholder interviews have been conducted, and the plan is in final draft form. This comprehensive update will build upon the achievements of the 2023 review, ensuring that Region 3's strategies remain data-driven, collaborative, and aligned with evolving regional and statewide economic priorities.

Together, these accomplishments demonstrate Region 3's continued leadership in shaping statewide policy, fostering collaboration, expanding industry focus areas, and strategically planning for long-term growth, cementing its role as a model for regional economic development across the Commonwealth.

Region 3 managed 17 active projects during FY25, with five projects reaching completion within the fiscal year. Of those completed, three were implementation projects with measurable outcomes, which are detailed below.

VI: Communication and Outreach

In FY25, the Region 3 Council continued to strengthen its communications and outreach efforts through its engagement with Letterpress Communications. This professional firm provides comprehensive



strategic consulting and implementation services, including social media management, public relations, graphic design, event communications, photography, videography, advertising, and website design and maintenance. Letterpress oversees Region 3's digital presence, managing content creation, posting, and engagement across Facebook, YouTube, and LinkedIn. The firm also maintains and updates targeted media lists at the local, regional, state, and national levels; develops and distributes press releases; pitches stories to national media outlets; and actively monitors economic development news throughout Region 3 across traditional and digital platforms.

VII: Project Pipeline

During FY25, Region 3 advanced a strong and diverse project pipeline reflecting strategic collaboration, innovation, and responsiveness to regional needs. The following projects demonstrate Region 3's commitment to workforce development, industry diversification, and leadership cultivation.



SOVA Partnership for Health Science Careers:

The Talent Pathways Initiative (TPI) planning project, led by the Blue Ridge Partnership for Health Science Careers and George Mason University, has been completed, with in-region support from Dr. Julie Brown. The final report was presented to the Region 3 Council on July 16th. Since then, Dr. Brown has transitioned to Provost at Averett University, affecting plans for IALR to advance the implementation phase. A Request for Interest was issued to identify additional organizations interested in serving as the project lead and grant applicant.

Industrial Skilled Trades Training Program:

Patrick & Henry, Danville, and Southside Virginia Community Colleges established a collaborative partnership in October 2024 to expand skilled trades training and credentialing, supported by a \$1 million grant from Virginia Community College System's Chancellor Dore. A Region 3 Per Capita implementation grant, estimated to total approximately \$1 million, is being developed to create a unified workforce training initiative in electrical, HVAC, carpentry, and plumbing/pipefitting. The project, led by Patrick & Henry Community College, will include equipment acquisition and



instructional personnel at each institution. The proposal will be reviewed by the Project Review Committee and Region 3 Council in October for submission to DHCD by October 31, 2025.



<u>Controlled Environment Agriculture (CEA) Innovation Center Expansion:</u>

The CEA Innovation Center, led by Dr. Scott Lowman, is seeking to expand its research capacity with a new prefabricated greenhouse to relieve current capacity constraints. A grant application to the Southern Crescent Regional Commission (SCRC) has been submitted, with approval anticipated by the end of September. Additional funding will be sought from the Tobacco Region Revitalization Commission and a GO Virginia Region 3 Per Capita grant request of approximately \$250,000—\$500,000 is expected for submission in January 2026.

Virginia Tech Additive Manufacturing and Advanced Materials (AM²) Tech Hub:



Launched in 2023 through a U.S. EDA grant, the AM² Tech Hub strengthens advanced manufacturing and materials innovation across Regions 2 and 3. Managed by Virginia Tech's Center for Economic and Community Engagement in partnership with IALR and regional businesses, the next phase will include building AM² Innovation Studios in Blacksburg and Danville, embedding Innovation Fellows, and launching an AM² Career Network. A statewide competitive GO Virginia grant is anticipated for early 2026.

Blue Ridge Innovation Corridor (BRIC):

The Blue Ridge Innovation Corridor aims to create Virginia's first inter-regional economic zone linking advanced manufacturing and biotechnology across Regions 2 and 3. This planning initiative will leverage assets across more than 25 localities, from Danville and Martinsville to Roanoke and Blacksburg, to establish a globally competitive innovation ecosystem. Coordination between consultant SIR, Region 2, and Region 3 staff is underway to develop a Statewide Competitive Planning Grant for submission by October 31, 2025, with State Board consideration in December 2025.



Virginia's Heartland Regional Economic Development Alliance:



Region 3 continues to support the Heartland Alliance in exploring opportunities to strengthen its regional site development capacity. Phase I will identify available industrial properties, assess Virginia Economic Development Partnership (VEDP) tier levels, and analyze up-tiering potential. Phase II may include identifying and evaluating large regional sites through a potential reorganized

Heartland Regional Industrial Development Facilities Authority. Future applications are contingent upon the Alliance's IRS nonprofit designation and Amelia County's full membership.

Region 3 Leadership Development Project:

Building on the Region 3 Council's focus on leadership capacity, discussions have been initiated with the University of Virginia's Sorensen Institute for Political Leadership and the Virginia Institute of Government to establish a community leadership program aligned with the SOVA Rise Collaborative. A completed report (August 2024) recommends pursuing an Enhanced Capacity Building feasibility study to define the program's structure, outcomes, and partnerships. A GO Virginia funding strategy will be developed once the GO Virginia Board makes funding available.

RE: Southern Virginia Partnership for Health Sciences Careers_ Request for Letters of Interest for a Lead Organization

At its meeting on September 17th, the Executive Committee received an update on the status of the Southern Virginia Partnership for Health Science Careers (SOVA Partnership).

The following is the information presented to the Executive Committee:

- The Talent Pathways Initiative planning project was completed by the project principals
 with the Blue Ridge Partnership for Health Science Careers (C. Lawrence) and George
 Mason University (Dr. C. Sutter). Dr. Julie Brown (IALR) has provided in-region leadership
 and staffing support to the SOVA Partnership. This report was presented to the Region 3
 Council at its meeting on July 16th.
- Since that time, Dr. Brown has left IALR and begun serving as Provost of Averett University. She had been serving as the in-region coordinator for the SOVA Partnership.
- A meeting of the SOVA Partnership members was held on September 12th to discuss
 possible paths forward to operationalize the SOVA Partnership. All voiced commitment to
 support the SOVA Partnership and its work going forward.
- At its meeting on Wednesday, September 17th, the Executive Committee received information about the SOVA Partnership's commitment to continue with its work. The committee members discussed potential options to find a lead organization to support and coordinate the work of the SOVA Partnership.
- Accordingly, the Executive Committee approved the preparation and posting of a Request for Letters of Interest from GO Virginia eligible organizations to serve as the Lead Organization for the Southern Virginia Partnership for Health Science Careers (SOVA Partnership). In this role, the selected organization will prepare and submit a GO Virginia Region 3 Per Capita Implementation Grant to support and coordinate the SOVA Partnership.

A copy of the request is attached for your reference.

• The Request for Letters of Interest was prepared and announced on Friday, September 26th. The request was sent to all members of the SOVA Partnership and posted on the GO Virginia Region 3 website deadline for submitting letters of interest was Wednesday, October 8th.
